The District is not responsible for the quality of the washer purchased and does not warranty any washer, or any fixture comprising a component in any washer, or the installation of any washer. The District does not warrant or guarantee lower water bills as a result of participating in the Program. The District is not responsible for any damage that may occur to applicant's property as a result of removing the washer or installing the new washer under this program.

The undersigned agrees to hold harmless Contra Costa Water District, its directors, officers, and employees from and against all loss, damage, expense and liability resulting from or otherwise relating to the purchase, installation, use, or removal of a toilet. **By signing this form I agree that I have read, understand, and agree to the terms and conditions of this rebate program, including the *Program Terms and Conditions for Participation* section on the back of this application (see reverse side).**

Program Terms and Conditions for Participation

1. All participants are subject to a washer inspection prior to receiving a rebate.
2. Program is subject to available funds and the District reserves the right to alter the program at anytime without notice.
3. District reserves the right to deny any applicant for participation that does not meet the program requirements herein.
4. Only High-Efficiency Commercial Washers approved by the Consortium for Energy Efficiency CEE (www.cee1.org) qualify for a rebate. The model number(s) of the washer(s) purchased must be on the CEE List of Qualifying Washers on the day of purchase.
5. This program applies to CEE list of approved Commercial Washers purchased on or after January 1, 2009. Applications will be processed until funds are depleted and are subject to the availability of funds.
6. Qualifying washers(s) must be installed before submitting rebate application.
7. Rebate Application must be postmarked within 60 days of purchase date.
8. Approved washer(s) must be installed within the CCWD Service Area: Antioch, Bay Point, Clayton, Clyde, Concord, Martinez, Oakley, Pacheco, Pittsburg, Pleasant Hill (parts), Port Costa, and Walnut Creek (parts).
9. New High-Efficiency Commercial washer(s) must have a Water Factor (W.F) of 7.5 or less.
10. Original dated sales receipt for new washer(s) must be submitted with the application.
11. Incomplete applications and those without the original dated sales receipt will be denied.
12. Applicant's Water Bill Account Number must be provided on the application.
13. Rebate amount applies to purchase of approved washer only.
14. CCWD is not responsible for rebates lost or delayed in the mail.
15. Applicant name must be the same as water account customer of record.
